



2016/2017 FINANCIAL INFORMATION Hybrid-Homeschool Wednesday Option

Tuition:

The chart below indicates the rates for the oldest enrolled child (1st child) and the family incentive rates for additional registered children. To determine your tuition, add the amounts for each child.

Covenant Love Community Church financially supports the ministry of Covenant Love Community School and provides discounted tuition rates for their regularly tithing members. We also offer a special reduced rate to full-time pastors of \$1,000 per child.

CLCS contracts with FACTS Management Company to supply tuition payment options and manage any financial aid requests.

Registration Fee:

In addition to tuition, a non-refundable registration fee of \$100.00 per family is charged for admission and re-enrollment.

Optional School Activity Fee:

Students participating in the Hybrid-Homeschool Wednesday Option will be given the opportunity to participate in field trips taken by their grade level and other special school activities that occur on days other than Wednesday. If they choose to participate in these trips or events, they will pay the Student Activity Fee. The fee is \$40 per student in grades Pre-K – 8th. The 7th-8th Grade annual fall history field trip to Gettysburg, PA or Boston, MA is available for an additional fee. **Please note that these field trips and activities are normally only a portion of the school day.** Homeschoolers will need to be dropped off and picked up at the beginning and end of the trip/activity.

Late Enrollment Fee:

As our program will need to be adjusted for additional students, a fee of \$60 will be charged for any student enrolled after September 1.

Early Withdrawal Fee:

Because we must plan our operating budget in advance of each school year, we depend upon families to pay their tuition for the entire year. If parents withdraw their children from school prior to the end of the year, it will be necessary to charge an early withdrawal fee of 20% of the tuition balance per student.

Membership status change:

If a family's membership at Covenant Love Church ceases, then the tuition rate will automatically be adjusted to the standard rates.



TUITION PAYMENT POLICY & FINANCIAL AID Hybrid-Homeschool Wednesday Option

Due Date: Tuition is due by August 10th of the upcoming school year. A \$30 Early Payment Incentive will be given to each family who pays their standard tuition rate in full by August 10th.

Tuition Payment Plans: For families who would prefer to spread tuition payments over the course of the school year, we have contracted with FACTS Management to handle those tuition payment plans. Families may click on the FACTS logo on the school's homepage (www.clcschool.org) to set up an account for automatic online tuition payments. Tuition payments are due on either the first or the tenth of each month based on the payment plan you choose. The first payment is due in August.

Delinquent Tuition Payments: Any delinquencies will be handled by FACTS Management. If there is no long-term resolution to the problem, parents will be asked to withdraw their child(ren) from the school.

Early Withdrawal Fee: If parents opt to withdraw their child(ren) from the school prior to the end of the year, it will be necessary to charge an early withdrawal fee of 20% of the total tuition per student for each month of non-enrollment through June. Tuition will be pro-rated from September, and charged for the full month in which the withdrawal occurs. A statement of tuition paid and withdrawal fees owed will be issued from the business office. All payments must be made prior to the final day of enrollment.

Past Due Tuition & Continuing Enrollment: Provision for payment of any outstanding tuition needs to be made by July 31st in order for a student to be considered enrolled for the next year.
